AS THE ADOPTING PARTY I AGREE TO THE FOLLOWING PROVISIONS:

- _____ 1. **I understand that the adoption is not considered final until a follow-up call has been replied to. If I do not respond by the third call, I will expect a home visit from a representative.**
 - _____ 2. I agree to keep an identification tag attached to a properly fitted collar which will remain on the adopted pet at all times, whether inside or outside of the house, and to obtain all licenses required by local authorities.
 - _____ 3. I agree to provide the adopted animal with necessary inoculations at the intervals advised by my veterinarian. I will obtain immediate veterinary care at my own expense, should the animal become ill or injured.
 - _____ 4. I agree to keep the animal I am adopting as a house pet. If I have housebreaking or behavioral problems, I agree to contact a suitable trainer or behaviorist. I understand that making the animal an outside pet constitutes as grounds for Unconditional Love Foundation to reclaim the animal.
 - _____ 5. I agree to have the adopted animal under my control when it is not within the confines of my property. A secure fenced area will be provided for dogs, including shelter from the elements. The adopted animal will not be tied or chained.
 - _____ 6. I agree not to abuse or neglect the adopted animal.
 - _____ 7. If I am adopting a cat I agree the cat will remain strictly indoors, going outside only on a harness or into a secure cattery.
 - _____ 7. I understand that the Unconditional Love Foundation cannot guarantee the health, temperament or training of the above described animal and hereby release the Unconditional Love Foundation from any claim, cause of action or liability for any injury or damage to persons or property once the animal is in my possession.
 - _____ 8. I agree that if the Unconditional Love Foundation should determine at any time that any of the provisions of this agreement have not been fully complied with, I will return the animal to the Unconditional Love Foundation upon demand. If I fail to return the animal, the Unconditional Love Foundation shall have the right, without further notice or demand, to enter the premises where the animal may be, and remove the animal without process of law. Adopter agrees to waive all claims for trespass or damage.
- _____ RETURN POLICY: I understand that if I cannot keep the animal I am adopting for its lifetime, the adoption fee will not be returned and I agree to return the animal to Unconditional Love Foundation, no matter where I am living at my expense. I will not give the animal to friends, relations, another rescue organization or shelter without written consent from Unconditional Love Foundation. Failure to return the dog/cat to Unconditional Love Foundation will result in a fine of up to \$10000 plus court costs and related expenses.
